What is the purpose of this update?

Description of this fund

Objective: aims to deliver medium to long term capital growth through investing in quality businesses with strong growth prospects.

Strategy: provides exposure to a portfolio of actively managed New Zealand and Australian listed equities. The underlying fund is a high conviction fund where the portfolio will consist of companies Harbour have researched and have a high belief will perform over the medium to longer-term.

How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,096 (that is 10.96% of his initial \$10,000). This gives Anthony a total return after tax of \$1,056 for the period.



What does the fund invest in?


This shows the types of assets that the fund invests in.
