What is the purpose of this update?

This document tells you how the InvestNow Mercer Ethical Leaders Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to provide capital growth over the longer-term with moderate levels of volatility.

Strategy: provides exposure to a diversified fund that invests across asset types, with a slightly lower mix of income assets (e.g. bonds) and slightly higher mix of growth assets (e.g. shares). The underlying fund is managed to specific 'responsible investment' criteria which prohibit investments in certain companies or activities, and encourages investment in companies with strong environmental, social and governance characteristics.

What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



How has the fund performed?

Annual Return Graph

What fees are investors charged?

Investors in the InvestNow Mercer Ethical Leaders Balanced Fund are charged fund charges. In the year to 31 March 2023 these were:

Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,152 (that is 11.52% of his initial \$10,000). This gives Anthony a total return after tax of \$1,065 for the period.




What does the fund invest in?

This shows the types of assets that the fund invests in.



The fund targets a position of exposure to foreign currency (excluding Australian dollar shares) being 69% gross hedged back to the New Zealand dollar. For Australian dollar shares, the underlying fund targets a position of exposure being 50% gross hedged back to the New Zealand dollar. For all other asset classes, the underlying fund targets 100% gross hedging of foreign currency exposure back to the New Zealand dollar.

Notes
