What is the purpose of this update?

This document tells you how the InvestNow Mercer Ethical Leaders Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to provide capital growth over the longer-term with moderate levels of volatility and to outperform, over the medium term, the weighted average return of the market indices used to measure performance of the underlying funds/assets.

Strategy: provides exposure to a diversified fund that invests across asset types, with a slightly higher allocation to a mix of growth assets (e.g. shares and listed property) relative to a mix of income assets (e.g. cash and fixed income). The underlying fund is managed to specific 'sustainable investment' criteria which prohibit investments in certain companies or activities, and encourages investment in companies with strong environmental, social and governance characteristics.

What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

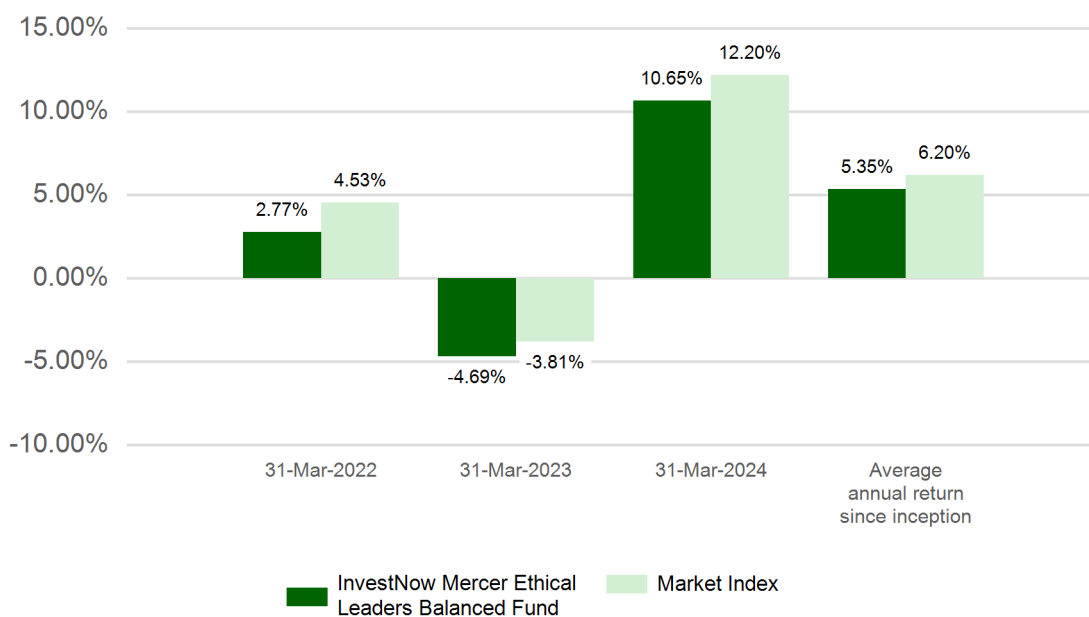

How has the fund performed?

Annual Return Graph

What fees are investors charged?

Example of how this applies to an investor

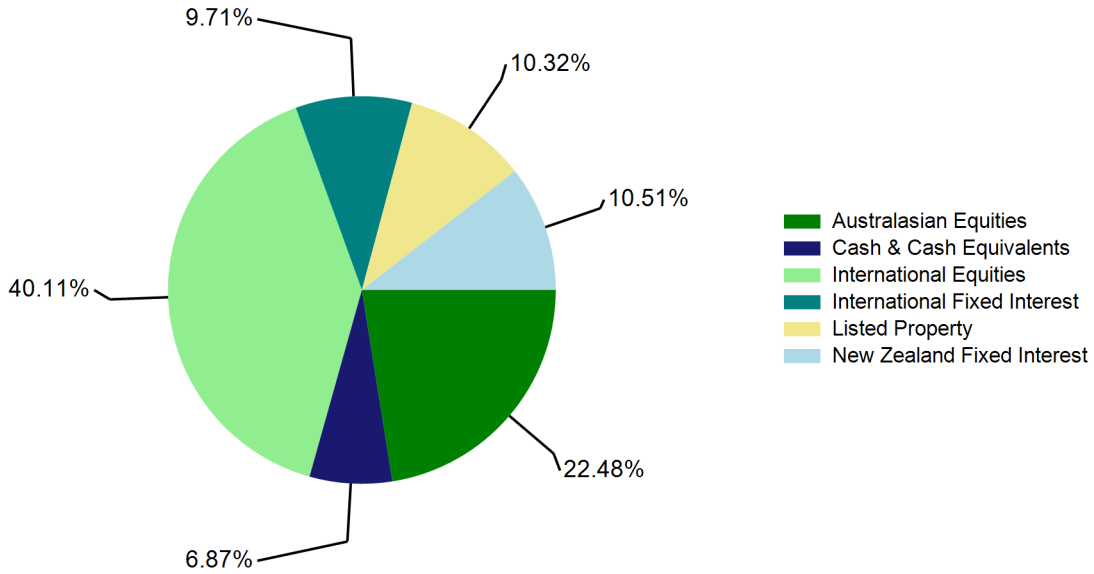
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$978 (that is 9.78% of his initial \$10,000). This gives Anthony a total return after tax of \$874 for the period.

What does the fund invest in?

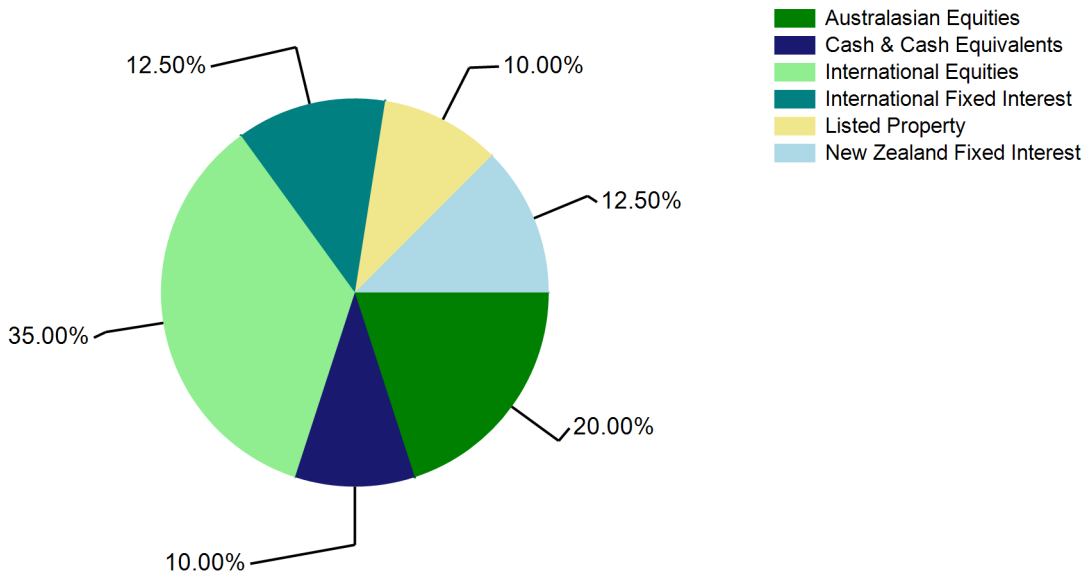
This shows the types of assets that the fund invests in.

Actual Investment Mix



The fund targets a position of exposure to foreign currency (excluding Australian dollar shares) being 69% gross hedged back to the New Zealand dollar. For Australian dollar shares, the underlying fund targets a position of exposure being 50% gross hedged back to the New Zealand dollar. For all other asset classes, the underlying fund targets 100% gross hedging of foreign currency exposure back to the New Zealand dollar.

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until October 2020 and fund returns thereafter.
- ii. Total fund charges reflects the fees and expenses incurred by the underlying fund in which the InvestNow Mercer Ethical Leaders Balanced Fund invests. This information has been sourced from the underlying fund manager in relation to the underlying fund's actual costs as a percentage of the average net asset value of the underlying fund.
