What is the purpose of this update?

This document tells you how the InvestNow Russell Investments Global Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

Objective: aims to outperform the MSCI ACWI - Net Index, before fees and tax, over the long term.

Strategy: provides exposure to an international shares fund that is actively managed using a multi-manager approach.



How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,586 (that is 15.86% of his initial \$10,000). This gives Anthony a total return after tax of \$1,387 for the period.

This shows the types of assets that the fund invests in.


Actual Investment Mix
