

## Fund Update

### What is the purpose of this update?

This document tells you how the InvestNow Russell Investments Global Fixed Interest Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

Objective: aims to provide a total return, before fees and tax, higher than the Bloomberg Global Aggregate Index - New Zealand dollar hedged over the long term.

Strategy: provides exposure to a portfolio of international fixed interest securities and is actively managed using a multi-manager approach. Targets being fully hedged back to New Zealand dollars.

### What are the risks of investing?

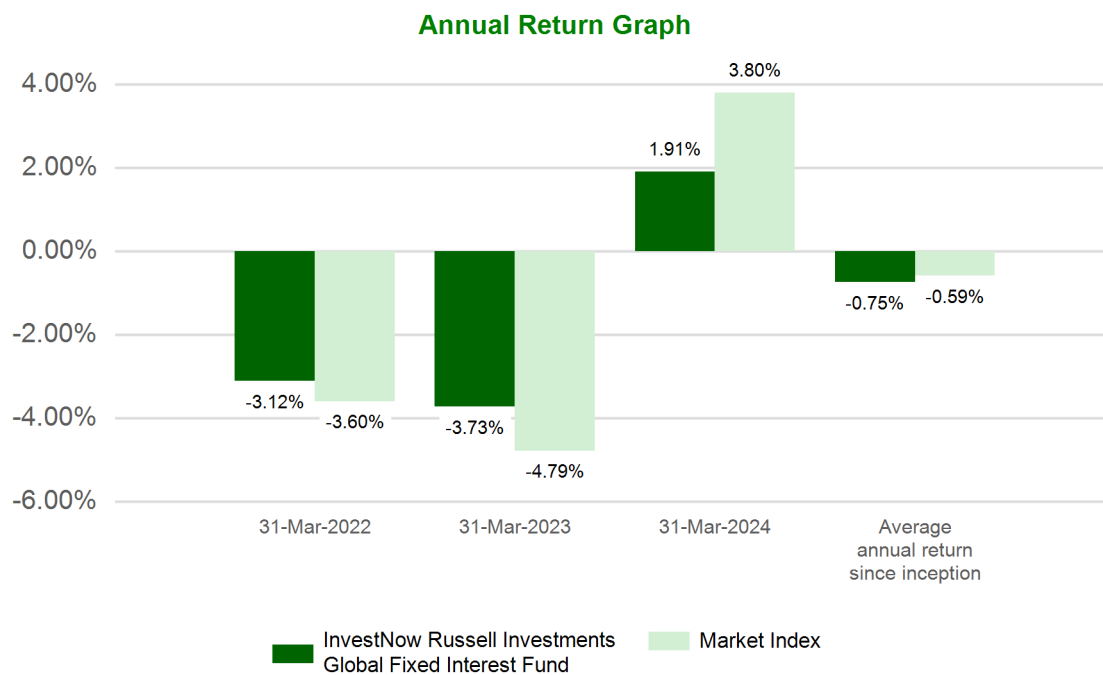

### Example of how this applies to an investor

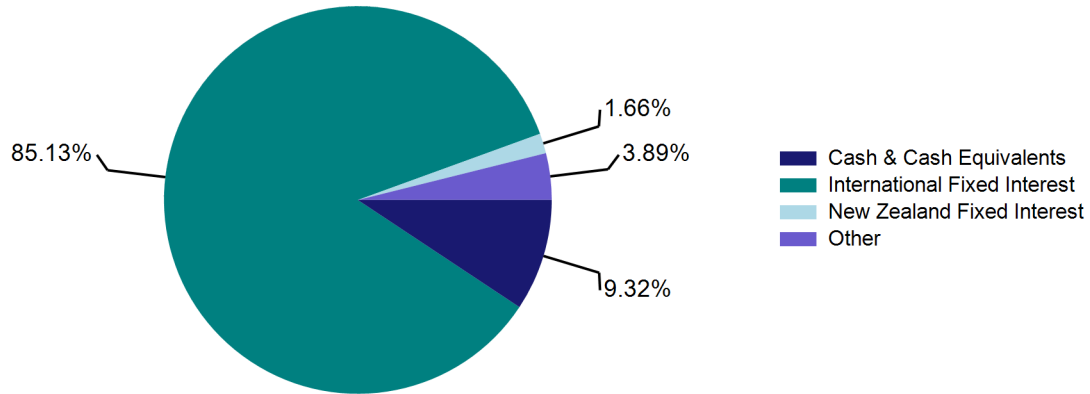
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,028 (that is 10.28% of his initial \$10,000). This gives Anthony a total return after tax of \$733 for the period.

This shows the types of assets that the fund invests in.

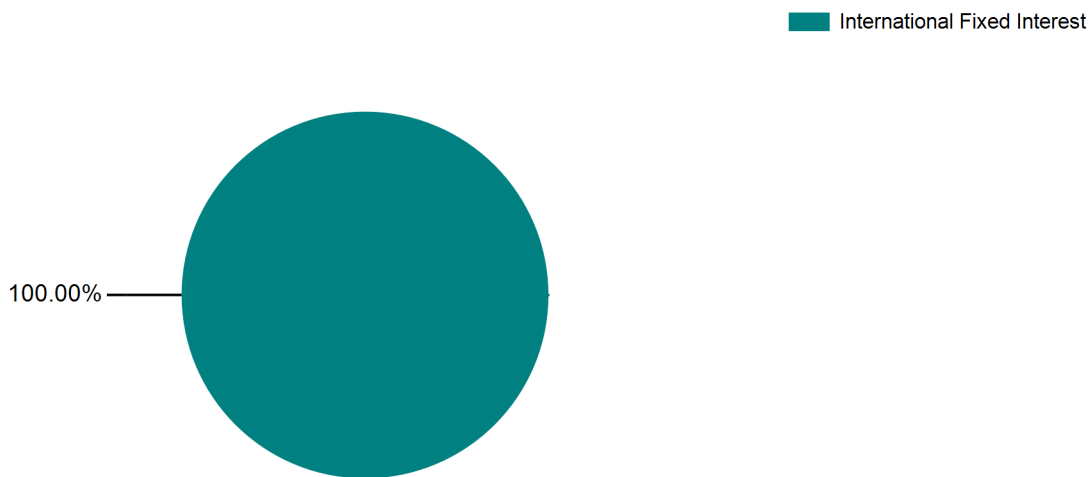
Actual Investment Mix
