What is the purpose of this update?

This document tells you how the InvestNow Harbour T. Rowe Price Global Equity Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

Objective: aims to provide long-term capital appreciation.

Strategy: provides exposure to an actively managed global shares fund that invests primarily in a portfolio of securities of companies which are traded, listed or due to be listed, on recognised exchanges and/or markets throughout the world.



How has the fund performed?

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$3,228 (that is 32.28% of his initial \$10,000). This gives Anthony a total return after tax of \$3,069 for the period.




What does the fund invest in?

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. - ii. Total fund charges reflects the fees and expenses incurred by the underlying fund in which the InvestNow Harbour T. Rowe Price Global Equity Fund invests. This information has been sourced from the underlying fund manager in relation to the underlying fund's actual costs as a percentage of the average net asset value of the underlying fund.
