What is the purpose of this update?

This document tells you how the InvestNow Harbour Active Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to deliver returns in excess of the Official Cash Rate (OCR) plus 5% over rolling 5-year periods.

Strategy: provides exposure to a diversified fund that invests in a portfolio weighted towards growth assets but with some income asset exposure.



How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,009 (that is 10.09% of his initial \$10,000). This gives Anthony a total return after tax of \$924 for the period.




What does the fund invest in?
