## What is the purpose of this update?

This document tells you how the InvestNow Clarity Global Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

Objective: aims to generate a better return than the MSCI All Country World Index (net dividends reinvested) in NZ dollars with 50% hedged to NZ dollars over the medium to long term.

Strategy: provides exposure to an actively managed global shares fund. The underlying investment manager uses a mix of fundamental and quantitative analysis to select companies.

## What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

## How has the fund performed?

The market index return is the MSCI All Country World Index (net dividends reinvested) in NZ dollars with 50% hedged to the NZ dollar. This has been the market index since 29 September 2023. The previous index was the MSCI All Country World ex-Tobacco Index (net dividends reinvested) in NZ dollars with 50% hedged to the NZ dollar. Market index returns are calculated using the previous market index since fund inception to 31 August 2023 and the current market index from 1 September 2023. ## Annual Return Graph

## Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$924 (that is 9.24% of his initial \$10,000). This gives Anthony a total return after tax of \$802 for the period.




## What does the fund invest in?

The fund has 99.83% of its assets denominated in foreign currencies of which 48.43% was hedged to NZD.

## Notes
