#### What is the purpose of this update?

This document tells you how the InvestNow Fisher Funds Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **Description of this fund**

Objective: aims to grow your investment over the long term by investing mainly in growth assets.

Strategy: provides exposure to a diversified fund that is best suited to a long-term investor who can tolerate volatility of returns in the expectation of potential higher returns, and has time on their side.

#### What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



### How has the fund performed?

# What fees are investors charged?

Investors in the InvestNow Fisher Funds Growth Fund are charged fund charges. In the year to 31 March 2024 these were:

## Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$372 (that is 3.72% of his initial \$10,000). This gives Anthony a total return after tax of \$246 for the period.



# What does the fund invest in?


This shows the types of assets that the fund invests in.

Other refers to an investment in a portfolio of listed property and listed infrastructure assets.

The fund targets a position of being 100% hedged into NZD for international fixed interest but was 99.96% hedged at quarter end, 70% hedged into NZD for Australasian equities but was 71.91% hedged at quarter end, 50% hedged into NZD for international equities but was 55.70% hedged at quarter end and 70% hedged into NZD for property and infrastructure assets but was 72.39% hedged at quarter end.

#### **Notes**

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until July 2021 and fund returns thereafter.
- ii. Total fund charges reflects the fees and expenses incurred by the underlying fund in which the InvestNow Fisher Funds Growth Fund invests. This information has been sourced from the underlying fund manager in relation to the underlying fund's actual costs as a percentage of the average net asset value of the underlying fund.
