#### What is the purpose of this update?

This document tells you how the InvestNow Macquarie Global Listed Real Estate Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **Description of this fund**

Objective: to provide a gross return above the FTSE EPRA/ NAREIT Developed Total Return Index with net dividends reinvested (100% hedged to the New Zealand dollar on an after-tax basis), on a rolling three year basis.

Strategy: provides exposure to an actively managed fund that invests in a global portfolio of property securities listed on stock exchanges around the world. Environmental, Social and Governance characteristics are integrated into the investment process.

#### What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



#### How has the fund performed?

#### Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$279 (that is 2.79% of his initial \$10,000). This gives Anthony a total return after tax of \$181 for the period.



What does the fund invest in? This shows the types of assets that the fund invests in.

The fund targets a position of being fully hedged back to the New Zealand dollar.

#### Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until October 2020 and fund returns thereafter.
- ii. Total fund charges reflects the fees and expenses incurred by the underlying fund in which the InvestNow Macquarie Global Listed Real Estate Fund invests. This information has been sourced from the underlying fund manager in relation to the underlying fund's actual costs as a percentage of the average net asset value of the underlying fund.
