#### What is the purpose of this update?

This document tells you how the InvestNow Macquarie NZ Cash Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **Description of this fund**

Objective: aims to provide a gross return above the return of the Bloomberg NZBond Bank Bill Index on a rolling 12 month basis.

Strategy: provides exposure to an actively managed portfolio of bank bills, floating rate notes and short term deposits and securities, and is a very low risk investment product that targets capital security. Environmental, Social and Governance characteristics are integrated into the investment process where applicable.

# What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



#### How has the fund performed?

#### What fees are investors charged?


#### Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$511 (that is 5.11% of his initial \$10,000). This gives Anthony a total return after tax of \$365 for the period.

# Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. - ii. Total fund charges reflects the fees and expenses incurred by the underlying fund in which the InvestNow Macquarie NZ Cash Fund invests.
