What is the purpose of this update?

This document tells you how the InvestNow Antipodes Global Value Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to achieve absolute returns in excess of the MSCI All Country World Net Index in NZ dollars over the investment cycle (typically 3-5 years).

Strategy: provides exposure to a diversified portfolio of international shares which is actively managed.

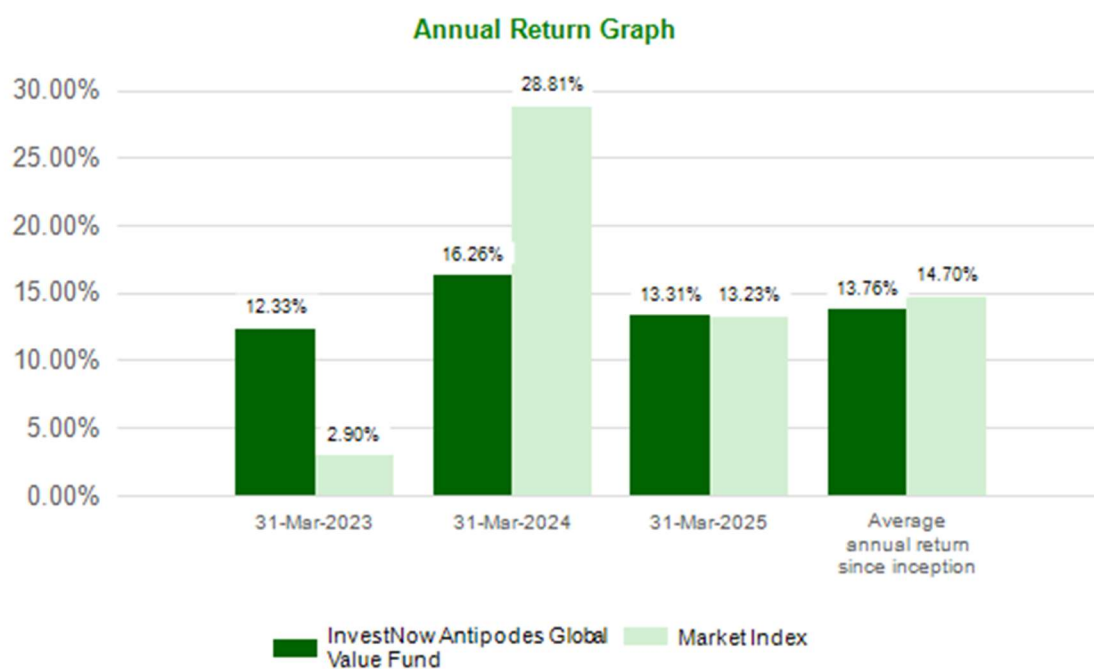

How has the fund performed?

The Underlying Fund's charges were reduced on 3 December 2024. Going forward, the underlying manager expect total fund charges to be less than in the table above. 'Manager's basic fee' includes an estimate of the charges incurred in the fund in which the underlying fund invests. The estimate incorporates information provided by the underlying fund manager as well as information sourced from the Underlying Fund's disclosure documents. Example of how this applies to an investor

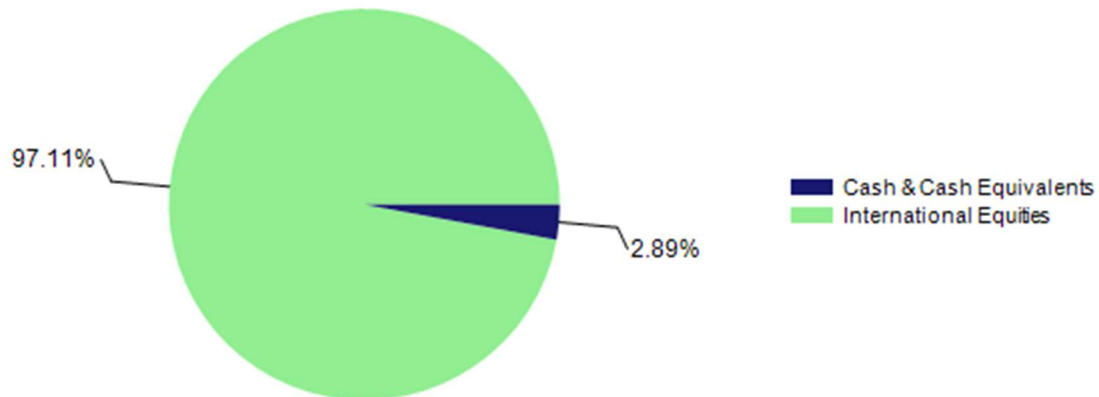
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$2,058 (that is 20.58% of his initial \$10,000). This gives Anthony a total return after tax of \$1,925 for the period.

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until March 2022 and fund returns thereafter.
- ii. Total fund charges reflects the fees and expenses incurred by the underlying fund in which the InvestNow Antipodes Global Value Fund invests. This information has been sourced from the underlying fund manager in relation to the underlying fund's actual costs as a percentage of the average net asset value of the underlying fund.
- iii. Kimi David had not been named as key personnel in a previous fund update for the fund.
