What is the purpose of this update?

This document tells you how the InvestNow Mercer Ethical Leaders Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to achieve a rate of return (after fees) that exceeds CPI increases by at least 2.5% per annum after tax and 3.5% before tax over a minimum of eight years, and to outperform, over periods of one year of greater, the weighted average return of the market indices used to measure performance of the underlying funds/assets.

Strategy: provides exposure to a diversified portfolio with a slightly higher allocation to a mix of growth assets (e.g. shares and listed infrastructure) relative to a mix of income assets (e.g. cash and fixed interest). The fund is managed with reference to environmental, social and governance factors and has exposure to investment strategies targeting sustainability themes.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



How has the fund performed?

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$659 (that is 6.59% of his initial \$10,000). This gives Anthony a total return after tax of \$589 for the period.



What does the fund invest in?


This shows the types of assets that the fund invests in.

Actual Investment Mix



The fund targets a position of exposure to foreign currency being 50% hedged back to the New Zealand dollar for international equities, although this may be actively managed between the range of 0% and 100%. For real estate investments and international fixed interest, the underlying fund targets 100% hedging of foreign currency exposure back to the New Zealand dollar.

Notes

- i. From 3 July 2025, the fund's name was changed to the InvestNow Mercer Sustainable Balanced Fund.
- ii. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until October 2020 and fund returns thereafter.
- iii. Total fund charges reflects the fees and expenses incurred by the underlying fund in which the InvestNow Mercer Ethical Leaders Balanced Fund invests. This information has been sourced from the underlying fund manager in relation to the underlying fund's actual costs as a percentage of the average net asset value of the underlying fund.
- iv. Kimi David had not been named as key personnel in a previous fund update for the fund.
