## What is the purpose of this update?

This document tells you how the InvestNow Mercer NZ Shares Passive Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

Objective: aims to provide a return that closely matches the return of the S&P/NZX 50 Index (on a gross basis and including imputation credits).

Strategy: provides exposure to a passively managed New Zealand shares portfolio that is designed to track the return of the S&P/NZX 50 Index. Environmental, Social and Governance characteristics are integrated into the underlying investment managers' investment processes.

## What are the risks of investing?

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

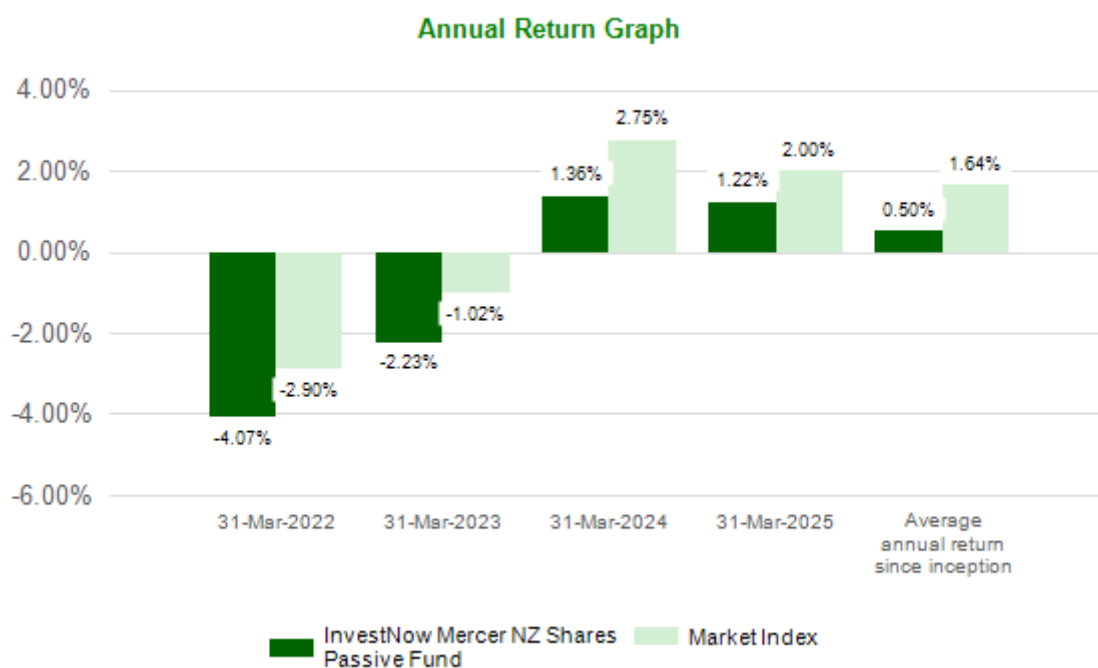

### What fees are investors charged?

\* Based on an increase in the 'Other management and administration charges' of the Mercer NZ Shares Passive Fund (**Underlying Fund**) to an estimated 0.35% from 1 August 2025, the manager of the Underlying Fund estimates that the total fund charges of the Underlying Fund will increase to 0.63% of the net asset value for the next scheme year. As it invests solely into the Underlying Fund, the InvestNow Mercer NZ Shares Passive Fund's total fund charges is also expected to increase to 0.63% of the net asset value for the next scheme year.

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). ### Example of how this applies to an investor

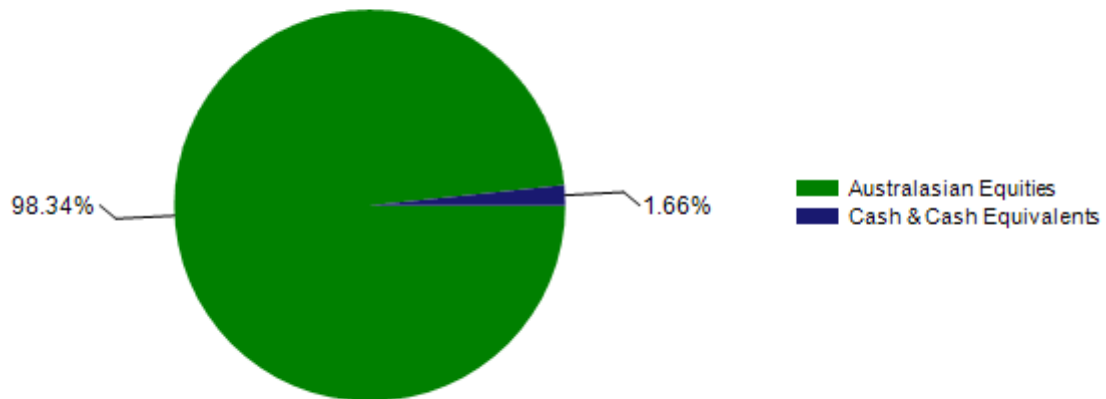
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$808 (that is 8.08% of his initial \$10,000). This gives Anthony a total return after tax of \$719 for the period.

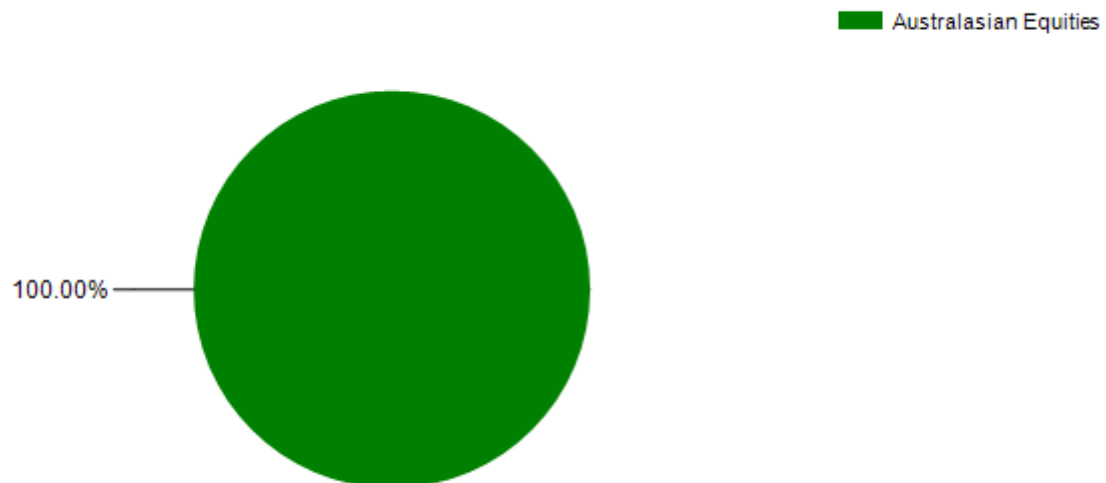
### What does the fund invest in?

## Notes

- A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. - Total fund charges reflects the fees and expenses incurred by the underlying fund in which the InvestNow Mercer NZ Shares Passive Fund invests. This information has been sourced from the underlying fund manager in relation to the underlying fund's actual costs as a percentage of the average net asset value of the underlying fund.
