What is the purpose of this update?

This document tells you how the InvestNow Foundation Series Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to provide returns that are broadly in line with the return of the underlying fund's investment benchmark before fees and tax over the long-term.

Strategy: provides exposure to a diversified fund that invests in a balance of income and growth assets.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

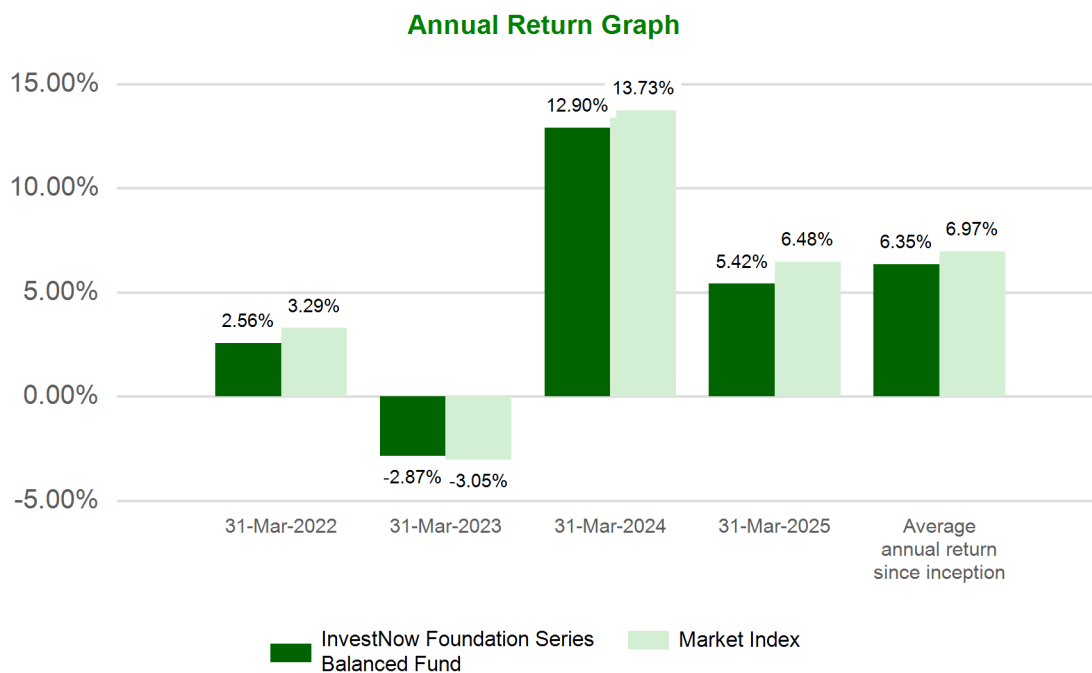

How has the fund performed?

Example of how this applies to an investor

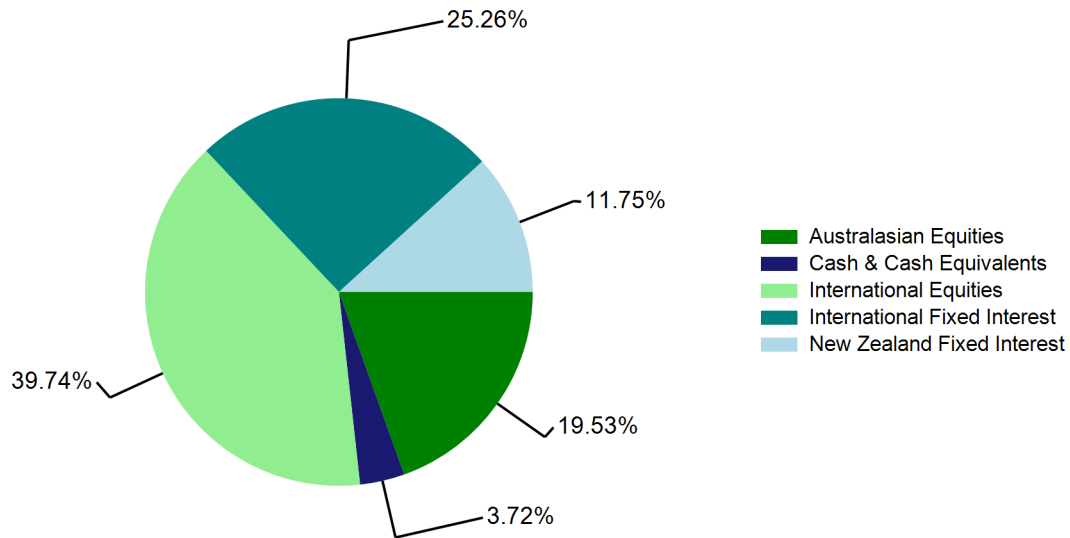
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,138 (that is 11.38% of his initial \$10,000). This gives Anthony a total return after tax of \$1,061 for the period.

What does the fund invest in?

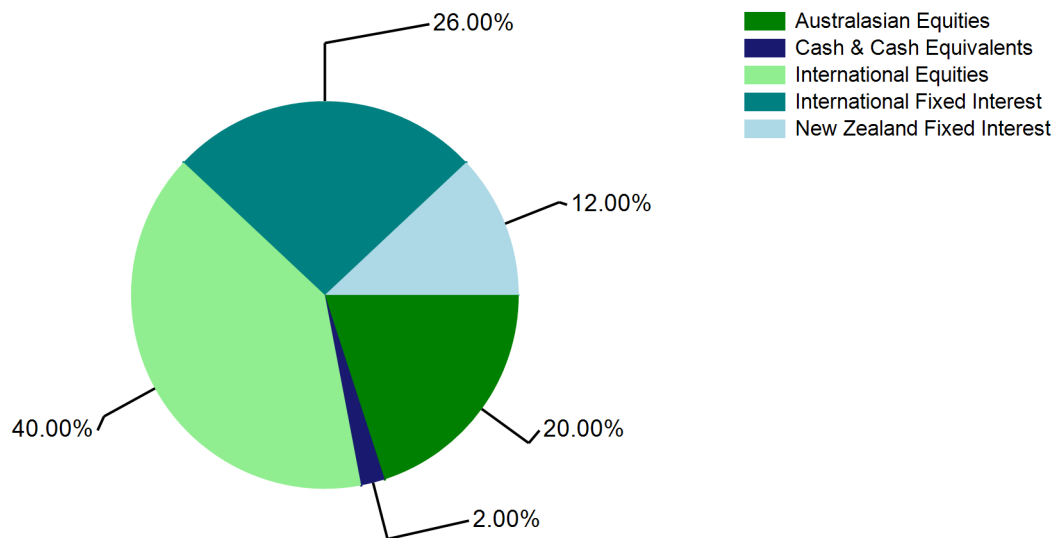
This shows the types of assets that the fund invests in.

The fund has foreign currency exposure and targets currency positions being fully hedged on international fixed interest assets and 50% hedged on international equity assets. Foreign currency exposure is hedged by the underlying funds.
