What is the purpose of this update?

This document tells you how the InvestNow Foundation Series Global ESG Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to provide returns that are broadly in line with the return of the underlying fund's investment benchmark before fees and tax over the long-term.

Strategy: provides exposure to an underlying fund that invests into ETFs that invests in shares of large, mid-sized and small companies listed on international stock markets. The underlying fund incorporates certain responsible investment considerations and is exposed to investment strategies that seek to limit exposure to companies involved in specific business practices.

Example of how this applies to an investor

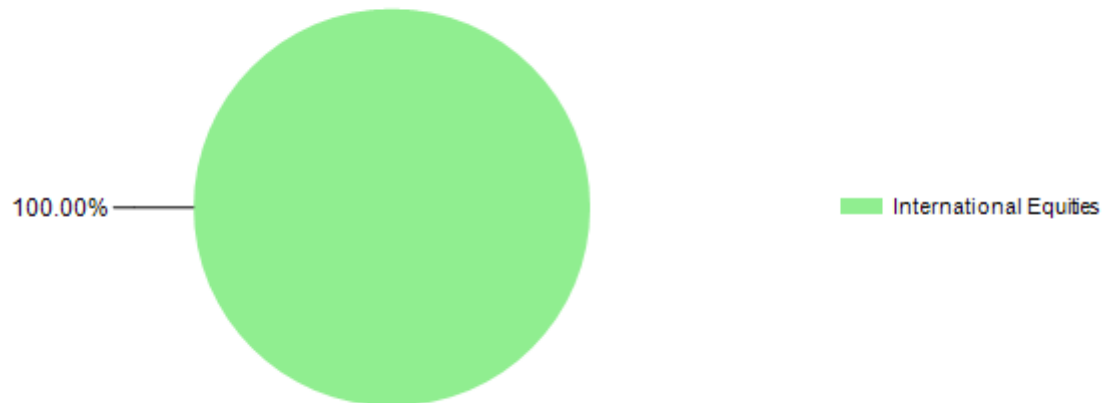
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund on the first day of the month following the fund's receipt of its first contribution, 1 August 2025 and did not make any further contributions. At the end of the period to 30 September 2025, Anthony received a return after fund charges were deducted of \$834 (that is 8.34% of his initial \$10,000). This gives Anthony a total return after tax of \$810 for the period.

Notes

- A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years.
