What is the purpose of this update?

This document tells you how the InvestNow Foundation Series Global ESG Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to provide returns that are broadly in line with the return of the underlying fund's investment benchmark before fees and tax over the long-term.

Strategy: provides exposure to an underlying fund that invests into ETFs that invests in shares of large, midsized and small companies listed on international stock markets. The underlying fund incorporates certain responsible investment considerations and is exposed to investment strategies that seek to limit exposure to companies involved in specific business practices.

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund on the first day of the month following the fund's receipt of its first contribution, 1 August 2025 and did not make any further contributions. At the end of the period to 30 September 2025, Anthony received a return after fund charges were deducted of \$834 (that is 8.34% of his initial \$10,000). This gives Anthony a total return after tax of \$810 for the period.




What does the fund invest in?

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until July 2025 and fund returns thereafter.
- ii. As the InvestNow Foundation Series Global ESG Fund only started accepting contributions on 3 July 2025 historical fee information is not available. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
