What is the purpose of this update?

This document tells you how the InvestNow Mercer Responsible Hedged Global Fixed Interest Index Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to provide a return that closely matches the return of the Bloomberg MSCI Global Aggregate SRI Select ex-Fossil Fuels Index (100% hedged to the New Zealand dollar on an after-tax basis).

Strategy: provides exposure to a passively managed international fixed interest portfolio that is designed to track the return of the Bloomberg MSCI Global Aggregate SRI Select ex-Fossil Fuels Index (100% hedged to the New Zealand dollar on an after-tax basis). The Underlying Fund is managed to specific 'sustainable investment' criteria which aim to avoid investments in certain companies or activities, and encourage investment in companies with strong environmental, social and governance characteristics.

What are the risks of investing?



How has the fund performed?

What fees are investors charged?

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$137 (that is 1.37% of his initial \$10,000). This gives Anthony a total return after tax of \$99 for the period.



What does the fund invest in?


This shows the types of assets that the fund invests in.

Notes
