What is the purpose of this update?

This document tells you how the InvestNow Pathfinder Ethical Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: focuses on ethical investing to achieve medium to high returns with a higher risk focus.

Strategy: provides exposure to a diversified ethical portfolio with a higher exposure to growth assets and a lower exposure to income assets.




How has the fund performed?

What fees are investors charged?

Investors in the InvestNow Pathfinder Ethical Growth Fund are charged fund charges. In the year to 31 March 2025 these were:

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.


Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$937 (that is 9.37% of his initial \$10,000). This gives Anthony a total return after tax of \$879 for the period.



What does the fund invest in?


This shows the types of assets that the fund invests in.

The target currency hedging is 50% of non-NZD equity exposure and 100% of non-NZD fixed interest exposure (actual hedging level was 50.57% at 30 September 2025 (this will change over time)). Total unhedged foreign currency exposure is 36.28% of the net asset value of the fund at 30 September 2025 (this will change over time).

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until May 2021 and fund returns thereafter.
- ii. Total fund charges reflects the fees and expenses incurred by the underlying fund in which the InvestNow Pathfinder Ethical Growth Fund invests. This information has been sourced from the underlying fund manager in relation to the underlying fund's actual costs as a percentage of the average net asset value of the underlying fund.
