

## Fund Update

- **InvestNow Russell Investments Hedged Global Shares Fund**

This fund update was first made publicly available on: 30 October 2025

This is a replacement fund update. It replaces the previous fund update for the quarter ending on 30 June 2025, first made publicly available on 28 July 2025. This replacement has corrected the total fund charges in the "What fees are investors charged?" section.

### What is the purpose of this update?

This document tells you how the InvestNow Russell Investments Hedged Global Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

Objective: aims to outperform the MSCI ACWI - Net Index 100% Hedged to NZD, before fees and tax, over the long term.

Strategy: provides exposure to an international shares fund that is actively managed using a multi-manager approach. The underlying fund targets being fully hedged back to New Zealand dollars.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

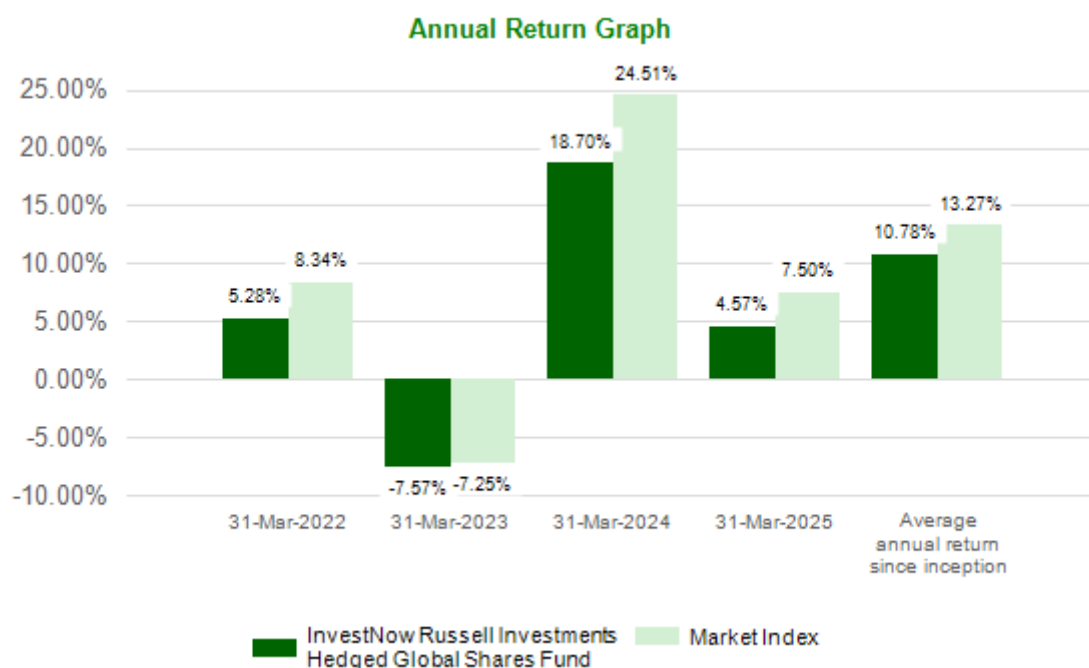

### Example of how this applies to an investor

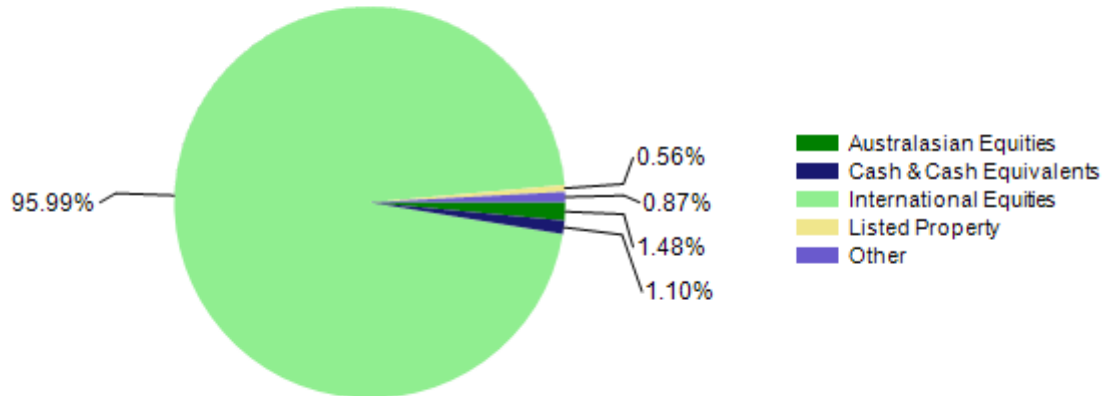
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,063 (that is 10.63% of his initial \$10,000). This gives Anthony a total return after tax of \$933 for the period.

## Notes
