This is a replacement fund update. It replaces the previous fund update for the quarter ending on 30 June 2025, first made publicly available on 28 July 2025. This replacement has corrected the total fund charges in the "What fees are investors charged?" section.

What is the purpose of this update?

This document tells you how the InvestNow Russell Investments Global Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to outperform the MSCI ACWI - Net Index, before fees and tax, over the long term.

Strategy: provides exposure to an international shares fund that is actively managed using a multi-manager approach.

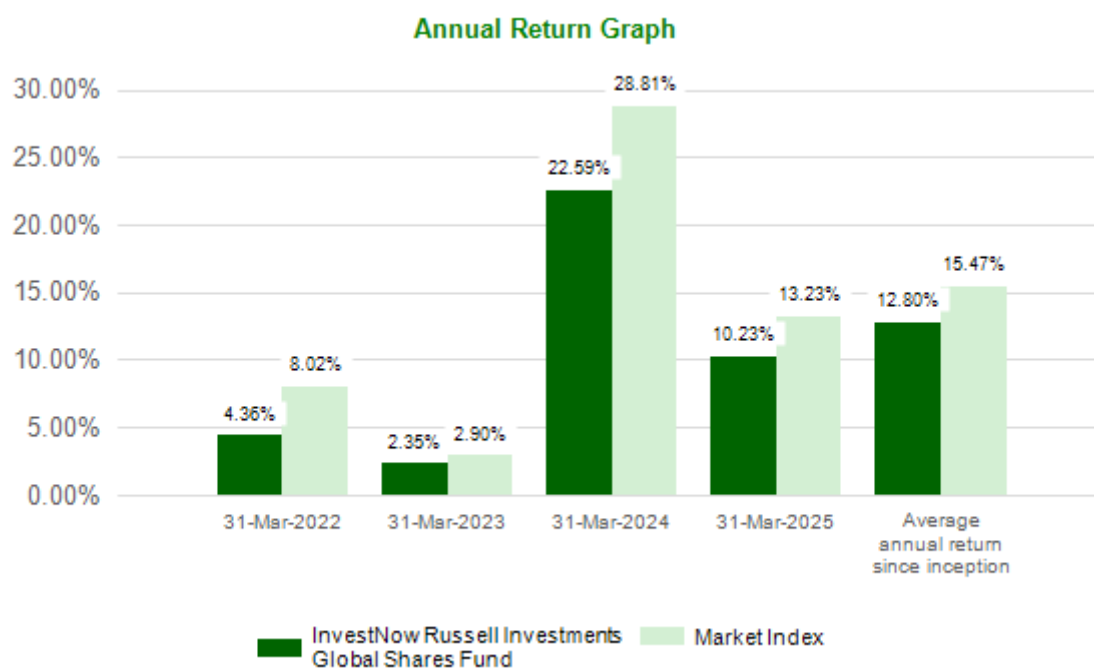

Example of how this applies to an investor

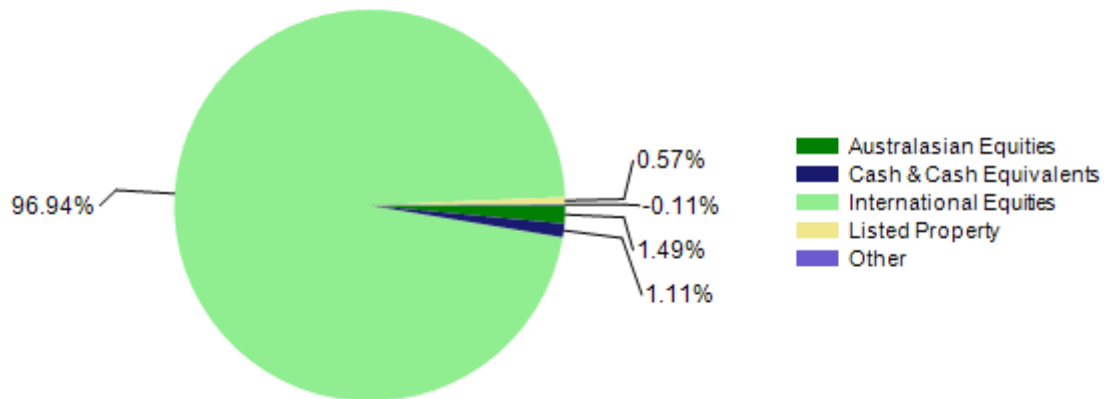
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,386 (that is 13.86% of his initial \$10,000). This gives Anthony a total return after tax of \$1,258 for the period.

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until October 2020 and fund returns thereafter.
- ii. Total fund charges reflects the fees and expenses incurred by the underlying fund in which the InvestNow Russell Investments Global Shares Fund invests. This information has been sourced from the underlying fund manager in relation to the underlying fund's actual costs as a percentage of the average net asset value of the underlying fund.
- iii. Kimi David had not been named as key personnel in a previous fund update for the fund.
