This document gives you important information about this investment to help you decide whether you want to invest. ## 1. Key information summary

### What is this?

This is a managed investment scheme. Your money will be pooled with other investors' money and invested in various investments. FundRock NZ Limited ('we', 'us', 'our' or 'FundRock') will invest your money and charge you a fee for its services. The returns you receive are dependent on the investment decisions of FundRock and of its investment manager and the performance of the investments. The value of those investments may go up or down. The types of investments and the fees you will be charged are described in this document.

### What will your money be invested in?

There are three investment options ('Funds') offered under this Product Disclosure Statement ('PDS') for the Foundation Series Funds ('Scheme'). These investment options are summarised below. More information about the investment target and strategy for each investment option is provided in section 3, "Description of your investment options".

Investments in the Funds are redeemable on request. We may suspend or defer redemptions in certain circumstances set out in the trust deed governing the Scheme ('Trust Deed').

Your investment in a Fund can be sold but there is no established market for trading these financial products. This means that you may not be able to find a buyer for your investment.

## How will your investment be taxed?

The Funds offered under this PDS are portfolio investment entities ('PIEs').

The amount of tax you pay in respect of a PIE is based on your prescribed investor rate ('PIR'). ## 2. How does this investment work?

This PDS is an offer to purchase units in the Funds. The Funds are part of the Scheme, which is a managed investment scheme established under the Trust Deed.

The Funds provide investors with access to three low-cost portfolios diversified across asset classes (e.g. cash, bonds and equities) in both New Zealand and internationally. The Funds are managed with the objective of performing broadly in line with each Fund's benchmark.

As manager of the Funds, we have appointed InvestNow Saving and Investment Service Limited ('InvestNow') as the Investment Manager and Distributor for the Funds. As Investment Manager, InvestNow will be responsible for making decisions about what the Funds invest in, in accordance with the Statement of Investment Policy and Objectives ('SIPO') for the Scheme. As Distributor, InvestNow will be responsible for promoting the Funds to potential investors and providing ongoing support to existing investors.

The Funds currently invest in underlying funds selected by InvestNow. Details of each Fund's underlying specialist managers and portfolio configuration can be obtained by contacting InvestNow or the Manager.

The money you invest buys units in the Fund or Funds you choose. Units do not constitute legal ownership of the Fund's assets. A change in the value of the Fund's assets affects the price of your units. The unit price for each Fund will change as the market value of the Fund's assets changes.

The price of each unit you receive in a Fund depends on the value of the Fund at the time you invest and any buy spread that applies. We calculate the unit price for each Fund by subtracting the total value of the Fund's liabilities from the market value of its assets and dividing that number by the number of units the Fund has issued. The unit price is normally calculated each business day.

No assets of a Fund will be available to be applied to meet the liabilities of any other Fund in the Scheme.

Public Trust is the supervisor ('Supervisor') of the Scheme and, in that role, monitors and supervises our management of the Funds. The assets of the Funds are held in independent custody by Adminis NZ Limited ('Adminis'), who has been appointed by the Supervisor.

The significant benefits of investing in the Funds are:

- **Diversification and scale.** By pooling the money of all investors in the Funds, we can give investors exposure to a more widely diversified portfolio of underlying assets than they may be able to access themselves. This increased diversification can reduce risk. In addition, the scale of the Funds allows us to lower costs by negotiating better prices with service providers.
- **Professional investment management.** Employing the expertise and resources of a professional manager is particularly beneficial if you do not have the time or the skill to manage your own investments.
- **Simplified investing.** Fund managers take care of the administration involved in buying, selling, reporting and record keeping.
- **Low Cost.** Fees reduce returns to investors and are an important consideration.

The return on your investment comes from any increase or decrease in the unit price.

The Funds in this PDS do not currently distribute income or capital gains, but may elect to do so in the future. Any income or capital gains will currently be included in the unit price calculated for these Funds.

### **Making investments**

You can make lump sum or regular investments into the Funds. The application process is described in section 10, "How to apply".

The minimum initial investment for each Fund is \$5,000. Thereafter, the minimum additional investment is \$500 per Fund. These minimum amounts may be varied or waived at our discretion. Note that these minimum investment amounts may not apply if investments are made via an approved investment administration and custodial service platform, such as the InvestNow platform.

When you make an application into a Fund, we will apply your investment at the unit price for that Fund, adjusted for any applicable buy spread for that Fund.

We may, in our absolute discretion, refuse any application without giving any reason. If we refuse your application, your application payment will be returned to you in full, without interest.

### **Withdrawing your investments**

You may request redemption of some or all of your investment at any time. Payment will normally be made within 5 business days of receiving your redemption request. However, we may either defer or suspend Fund withdrawals.

Fund redemptions may be deferred if:

- we receive one or more redemption requests, within 60 Business Days, totalling more than 10% of Fund units on issue, and
- we consider deferral to be in the general interests of all Fund investors.

Fund redemptions may be suspended if we believe allowing investors to take their money out would not be workable or would prejudice investors generally. For instance, suspension could apply if we decide to wind up a Fund, or we are unable to realise underlying fund holdings. If withdrawals are suspended and you submit a withdrawal request, we will not process it until the suspension is lifted. Further information on the circumstances and conditions related to a suspension are set out in the Trust Deed.

In case of either a deferral or suspension, investors will receive the redemption price applicable at the end of the deferral or suspension period (or redemption prices in the case of deferred redemptions which are paid out over a period of time). In the case of either a deferral or suspension, it also means that there may be a delay in you getting your money out of the investment.

More information about deferrals and suspensions can also be found in the Other Material Information ('OMI') document for the Funds.

When you redeem all or part of your investment from a Fund, we will redeem your investment at the unit price for that Fund, adjusted for any applicable sell spread for that Fund.

We reserve the right to refuse a redemption request for less than \$500 worth of units or a redemption request that would result in you holding less than \$5,000 worth of units (except where all of your units are to be redeemed).

### **How to switch between Funds**

You can switch your investment between the Funds offered under this PDS or to any other fund currently being offered under the Scheme.

A switch from one Fund to another is treated as a redemption from one Fund and an application to invest in the other Fund. The minimum amount you can switch between Funds is \$500.

You will not be charged a switch fee but any applicable buy and sell transaction fees or buy and sell spreads will apply on each redemption and application for a switch. More information about the buy and sell transaction fees and buy and sell spreads can be found in section 5 of the relevant PDS, "What are the fees?".

## Responsible Investment

The approach to responsible investment for the Foundation Series Funds is for designated funds within the Scheme ('Designated Funds') to invest into underlying funds that express certain environmental, social, and governance ('ESG') considerations.

All funds offered under this PDS are classified as Designated Funds, with each of the Funds investing into underlying funds that predominantly express ESG considerations through specific negative screens.

Based on certain business involvement criteria and revenue thresholds, these negative screens seek to limit exposure to companies involved with specific business practices, including: anti-personnel landmines; chemical and biological weapons; cluster munitions; nuclear weapons; tobacco; thermal coal; military weapons; civilian automatic or semi-automatic firearms; alcohol; gambling; and pornography.

For additional detail on how responsible investment considerations are applied within Designated Funds (including screening limitations), and how certain terms and metrics, including business involvement criteria, are defined, please refer to the SIPO for the Scheme as well as the InvestNow Responsible Investment Statement. We can make changes to the SIPO of the Scheme in accordance with the Trust Deed and the Financial Markets Conduct Act 2013 ('FMC Act'). Before making changes to the SIPO, we will consider if the changes are in your best interests and consult with the Supervisor. We will give notice of changes to Fund investors prior to effecting any material change and any material changes to the SIPO will be advised in the Scheme's annual report. ## 4. What are the risks of investing?

### Understanding the risk indicator

Managed funds in New Zealand must have a standard risk indicator. The risk indicator is designed to help investors understand the uncertainties both for loss and growth that may affect their investment. You can compare funds using the risk indicator.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down (volatility). A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks (described under the heading 'Other specific risks') that are not captured by this rating.

This risk indicator is not a guarantee of a fund's future performance. The risk indicator is based on the returns data for the five years to 30 September 2025. While risk indicators are usually relatively stable, they do shift from time to time. You can see the most recent risk indicator in the latest fund update for these Funds.

### General investment risks

Some of the things that may cause the Funds' value to move up and down, which affect the risk indicator, are:

#### Asset allocation risk

The largest determinant of returns and volatility is the proportionate allocation to different asset classes. Accordingly, asset allocation will impact the overall returns of the Funds.

#### Interest rate and credit risk

The Funds invest in fixed interest securities and so are exposed to interest rate risk and credit risk.

Interest rate risk is the risk that the value of an investment changes due to movements in interest rates. If interest rates rise, the value of fixed interest securities falls. If interest rates fall, their value rises. Interest rates move for a range of factors including (but not limited to) the supply and demand for money, future inflation expectations, monetary policy, or market sentiment.

Credit risk is the risk a borrower is unable to repay the lender. The ability of the borrower to repay the lender depends on the financial position and financial prospects of the borrower.

#### Market and security specific risk

A key risk for the Funds is that prices of underlying shares fluctuate. Price fluctuations are generally attributable to a combination of:

- market risk, and
- security specific risk.

Factors that underpin market risk include expectations for economic growth, investor sentiment, interest rates and inflation. Market factors impact on all shares.

Security specific risk refers to factors that are particular to each stock or security. Examples of security specific risk include the level of company debt and the demand for a company's particular products or services. Additionally investor sentiment is one of the factors that will influence security specific risk.

#### **Currency risk**

The Funds invest offshore and hence are exposed to currency risk. Currency risk stems from the value of foreign currencies moving differently to the New Zealand dollar. For example, a fall in an investor's local currency can result in an increase in the value of their international investments.

The Funds manage currency risk by having international fixed interest assets fully hedged to the New Zealand dollar and international equity assets 50% hedged to the New Zealand dollar.

#### **Liquidity risk**

The Funds are exposed to liquidity risk.

Sometimes, when securities are not traded frequently or in large amounts or when market conditions are difficult, buying interest can dry up. This can make it hard for investors to sell securities at short notice and at a desired price. In periods of illiquidity, we may not be able to sell securities or may need to sell securities at a lower price than desired (possibly with higher transaction costs associated with the withdrawal), to pay withdrawal requests and the generally acceptable timeframe for satisfying withdrawal requests may not be able to be met.

Further information on how we try to minimise this risk can be found in the SIPO for the Scheme, and details on our liquidity management tools and the potential impacts of using those tools can be found in the OMI document for the Scheme.

#### **Benchmark tracking risk**

The Funds may invest in ETFs that provide investors with performance returns that are broadly in line with their benchmark index. There is a risk that this objective is not met due to differences in the ETFs' replication index versus the benchmark index, delays in investing cash and associated transactional costs. There is also the risk that an underlying ETF trades at a premium or discount to the value of its assets for reasons related to underlying liquidity. This means that there is a risk that the returns on the Funds will differ from the benchmark index.

#### **Other specific risks**

There are other risks that may affect returns for investors, which are not reflected in the risk indicator. These risks include:

#### **Passive management risk**

The Funds are exposed to underlying funds that feature passively managed investment strategies. Passive investing means that no active investment decisions are made and instead the aim is to track the underlying index regardless of the outlook for the securities that comprise the index. As such, there is a risk that returns are lower than what an active manager might be able to achieve by making active investment decisions.

## 5. What are the fees?

You will be charged fees for investing in the Funds. Fees are deducted from your investment and will reduce your returns. If we invest in other funds, those funds may also charge fees. The fees you pay will be charged in two ways:

- regular charges - for example, annual fund charges. Small differences in these fees can have a big impact on your investment over the long term.
- one-off fees - for example trading costs

The charges outlined above include all normal day-to-day fund costs and expenses including the following:

#### Annual fund charges:

- the management fee paid to us and the investment management fee paid to InvestNow;
- fees and expenses charged within any underlying funds in to which the Funds may invest;
- the Supervisor's fee;
- custody costs;
- costs incurred by us, the Supervisor and InvestNow in carrying out each of our respective duties (including the fees charged by auditors, solicitors, valuers and other advisers);
- the cost of obtaining market indices;
- bank account charges applicable to the Funds; and
- costs for administration services, including unit registry, asset registry, unit pricing and investment accounting costs and costs associated with the provision of financial information related to each Fund.

The annual fund charges do not include any extraordinary expenses such as costs of any litigation or unitholder meetings.

The annual fund charges are calculated and accrued daily and reflected in the unit price. The investment management charges and other fund charges are paid monthly.

#### GST

The GST treatment of each of these components varies. For example, GST is currently charged at 15% on the audit fee, while custody fees are an exempt supply for the purposes of GST. These percentages vary, and may change in the future, which is why GST has been estimated.

### Individual action fees and trading costs (% of amount contributed or withdrawn)

#### Individual action fees

There are no individual action fees currently being charged to investors in the Funds offered under this PDS.

### **Trading costs**

Buy/sell spreads – Any buy or sell spread will be a cost to you. The buy spread is added to the unit price when an investor invests into the Fund, and the sell spread is deducted from the unit price when an investor redeems from the Fund. The buy/sell spreads belong to the Fund and are not fees paid to us or any investment manager. The purpose of buy/sell spreads is to make sure that any transaction costs incurred as a result of an investor buying or selling units in a Fund are borne by that investor, and not by other investors in the Fund. There is no GST charged on buy/sell spreads.

We aim to set buy/sell spreads at levels which reflect expected trading costs. Buy/sell spreads in the table below are as at the date of this PDS and are indicative.

We may change the buy/sell spreads from time to time to reflect the latest trading costs and market conditions. In stressed market conditions buy/sell spreads may materially increase. There are no other one-off fees currently being charged to investors in the Funds offered under this PDS.

### **Example of how fees apply to an investor**

Anthony invests \$5,000 in the Foundation Series Balanced Fund.

He is charged management and administration fees, which work out to about \$18.50 (0.37% of \$5,000). These fees might be more or less if his account balance has increased or decreased over the year.

### **Estimated total fees for the first year**

Fund charges: \$18.50

### **The fees can be changed**

We can change fees from time to time. We can also add new fees. We may waive or decrease a management fee without notice. We may increase the management fee, or start charging additional fees, by giving you at least three months' notice. The rules about fee changes are in the Trust Deed, which can be found on the scheme register at [www.disclose-register.companiesoffice.govt.nz](http://www.disclose-register.companiesoffice.govt.nz).

We must publish a fund update for each Fund showing the fees actually charged during the most recent year. ## 6. What taxes will you pay?

Each Fund is a PIE. The amount of tax you pay is based on your PIR. To determine your PIR, go to [www.ird.govt.nz/roles/portfolio-investment-entities/find-my-prescribed-investor-rate](http://www.ird.govt.nz/roles/portfolio-investment-entities/find-my-prescribed-investor-rate). If you are unsure of your PIR, we recommend you seek professional advice or contact Inland Revenue. It is your responsibility to tell us your PIR when you invest or if your PIR changes. If you do not tell us, a default rate may be applied. If the rate applied to your PIE income is lower than your correct PIR, you will be required to pay any tax shortfall, as part of the income tax year-end process. If the rate applied to your PIE income is higher than your PIR any tax over-withheld will be used to reduce any income tax liability you may have for the tax year and any remaining amount will be refunded to you.
