This is a replacement fund update. It replaces the previous fund update for the quarter ending 31 December 2024, first made publicly available on 13 February 2025. This replacement has altered the wording under "What fees are investors charged?" to change "entry fee" and "exit fee" to "buy transaction fee" and "sell transaction fee" to align with the wording in the PDS.

What is the purpose of this update?

This document tells you how the InvestNow Foundation Series Hedged US 500 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to provide returns that are broadly in line with the return of the underlying fund's investment benchmark before fees and tax over the long-term. The underlying fund aims to have all foreign currency exposure hedged to the New Zealand dollar.

Strategy: provides exposure to a single sector fund that invests into an ETF that in turn invests in shares of the largest companies listed on stock markets in the United States.

What fees are investors charged?

Investors in the InvestNow Foundation Series Hedged US 500 Fund are charged fund charges which are:

The charges outlined above represent the fees charged within the underlying ETFs (external management fees) that the underlying fund invests into and have been estimated based on information in the underlying ETFs' disclosure documents. Note that the fees within the underlying ETFs are not tax deductible. Investors are charged each time they make a contribution to (buy transaction fee) or withdrawal from (sell transaction fee) the underlying fund. These fees are charged to cover the costs of the underlying brokerage, foreign currency exchange, transaction costs and investment management service fees associated with investing in the underlying investments. The underlying fund's current buy and sell transaction fees are 0.50%.

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). Example of how this applies to an investor

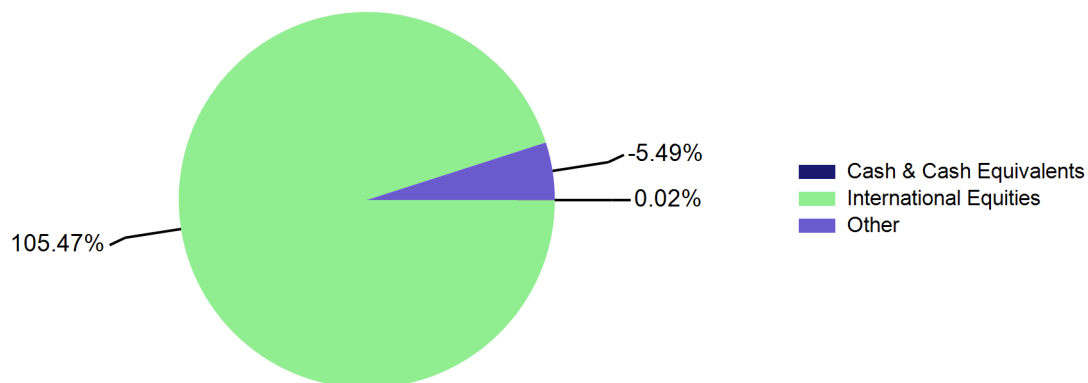
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund on the first day of the month following the fund's receipt of its first contribution, 1 March 2024 and did not make any further contributions. At the end of the period to 31 December 2024, Anthony received a return after fund charges were deducted of \$1,618 (that is 16.18% of his initial \$10,000). This gives Anthony a total return after tax of \$1,552 for the period.

What does the fund invest in?

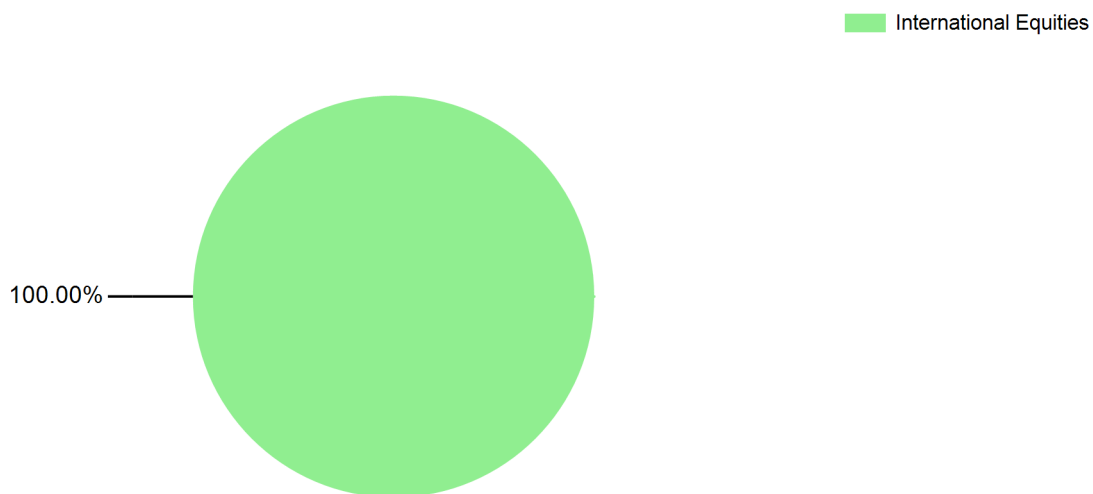
This shows the types of assets that the fund invests in.

Notes

- A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until February 2024 and fund returns thereafter.
- As the InvestNow Foundation Series Hedged US 500 Fund only started accepting contributions on 8 February 2024 historical fee information is not available. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
- The top 10 assets add up to more than 100% of NAV as the fund also has liabilities which offsets these assets.
