What is the purpose of this update?

This document tells you how the InvestNow Harbour Balanced Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to outperform its benchmark before fees and tax over a rolling 5-year period.

Strategy: provides exposure to a diversified fund that invests in a portfolio weighted towards growth assets but with some income asset exposure.



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 December 2025.




This shows the types of assets that the fund invests in.
