What is the purpose of this update?

This document tells you how the InvestNow Macquarie NZ Fixed Interest Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to provide a gross return above the return of the Bloomberg NZBond Composite 0+ Yr Index on a rolling three-year basis.

Strategy: provides exposure to an actively managed portfolio of fixed interest securities. It is a medium risk investment product, focusing predominantly on government bonds and corporate securities in the New Zealand market. Environmental, Social and Governance characteristics are integrated into the investment process where applicable.

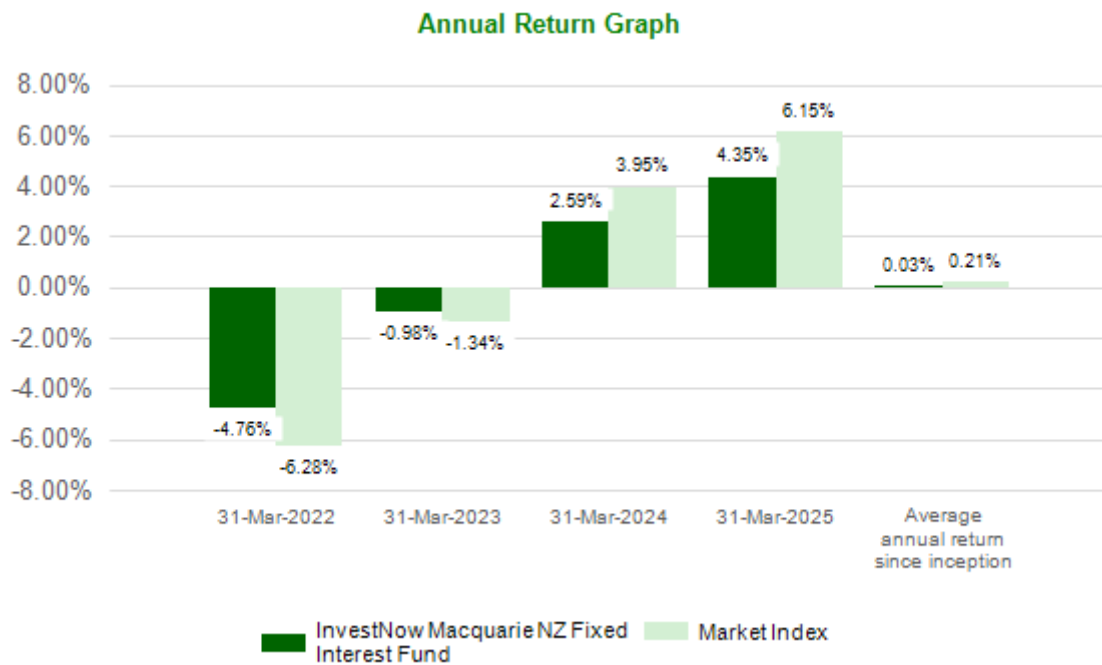

Example of how this applies to an investor

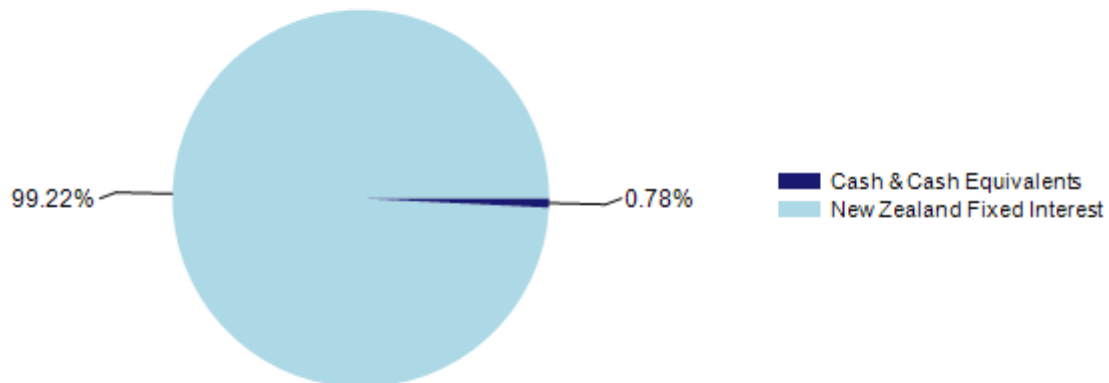
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$486 (that is 4.86% of his initial \$10,000). This gives Anthony a total return after tax of \$349 for the period.

What does the fund invest in?
