## What is the purpose of this update?

This document tells you how the InvestNow Milford Aggressive Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund


Objective: aims to maximise capital growth after the base fund fee, but before tax over the minimum recommended investment timeframe.

Strategy: provides exposure to a diversified fund that primarily invests in international shares, with a moderate allocation to Australasian shares.

## What are the risks of investing?

Risk indicator for the InvestNow Milford Aggressive Fund <sup>i</sup>.



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



## How has the fund performed?

**Annual Return Graph**



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 December 2025.

### What fees are investors charged?

Investors in the InvestNow Milford Aggressive Fund are charged fund charges. In the year to 31 March 2025 these were:

### Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,084 (that is 10.84% of his initial \$10,000). This gives Anthony a total return after tax of \$993 for the period.

This shows the types of assets that the fund invests in.


Actual Investment Mix

## Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. - ii. Total fund charges reflects the fees and expenses incurred by the underlying fund in which the InvestNow Milford Aggressive Fund invests. This information has been sourced from the underlying fund manager in relation to the underlying fund's actual costs as a percentage of the average net asset value of the underlying fund.
