What is the purpose of this update?

This document tells you how the InvestNow Russell Investments NZ Fixed Interest Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to provide a total return, before fees and tax, higher than the Bloomberg NZBond Composite 0+ Yr Index over the long term.

Strategy: provides exposure to a diversified portfolio of predominantly investment grade New Zealand dollar denominated fixed interest securities.

What are the risks of investing?



How has the fund performed?

Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$465 (that is 4.65% of his initial \$10,000). This gives Anthony a total return after tax of \$335 for the period.

What does the fund invest in?

This shows the types of assets that the fund invests in.


Actual Investment Mix



Foreign currency exposure was not hedged to New Zealand dollars as at 31 December 2025.

Note: 'Other' includes derivatives and global bond futures. The underlying fund's foreign currency fixed interest securities are largely hedged back to the New Zealand dollar. Investment in international fixed interest is restricted to the Australian fixed income market either through Australian denominated debt securities or derivative instruments.
