What is the purpose of this update?

This document tells you how the InvestNow Foundation Series Balanced Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to provide returns that are broadly in line with the return of the underlying fund's investment benchmark before fees and tax over the long-term.

Strategy: provides exposure to a diversified fund that invests in a balance of income and growth assets. The underlying fund incorporates certain responsible investment considerations and is exposed to investment strategies that seek to limit exposure to companies involved in specific business practices.

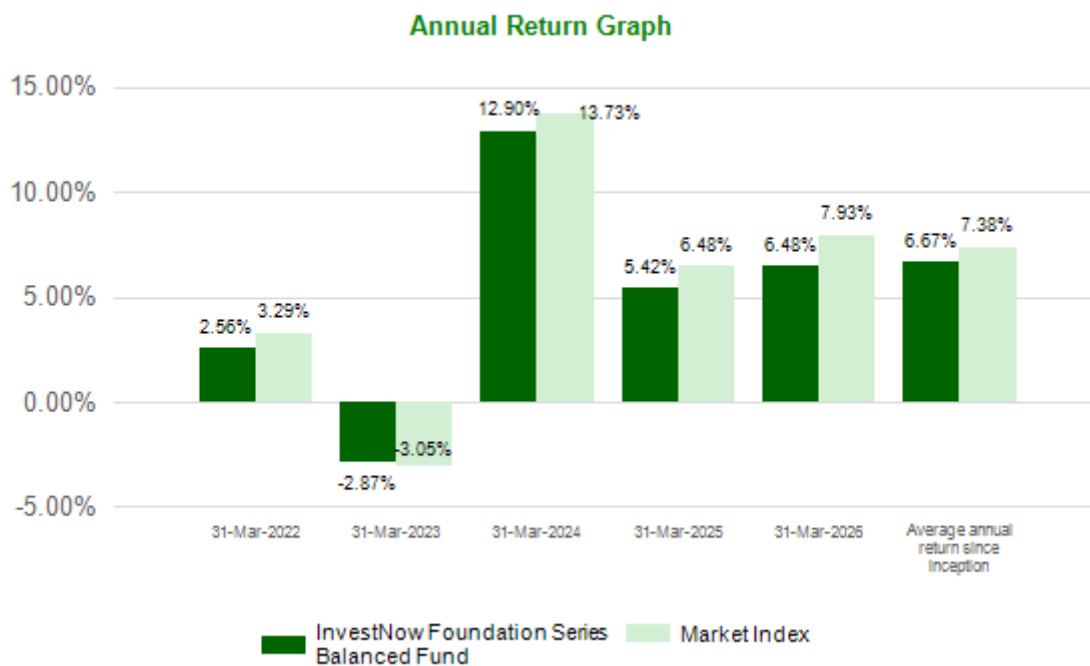

How has the fund performed?

Example of how this applies to an investor

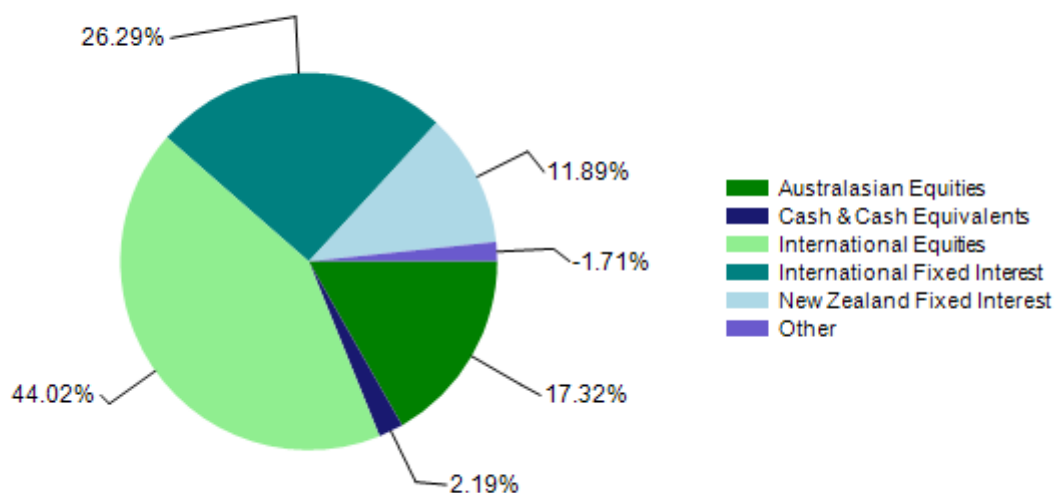
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,325 (that is 13.25% of his initial \$10,000). This gives Anthony a total return after tax of \$1,195 for the period.

Actual Investment Mix

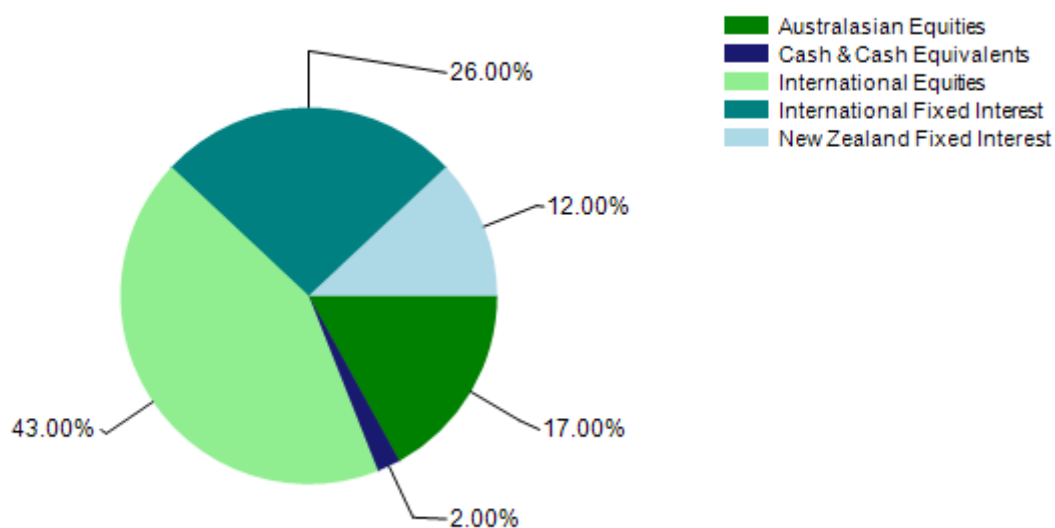


Foreign currency exposure was 68.65% hedged to New Zealand dollars as at 30 June 2026.

The fund has foreign currency exposure and targets currency positions being fully hedged on international fixed interest assets and 50% hedged on international equity assets.
