

# Fund Update

## What is the purpose of this update?

This document tells you how the InvestNow Milford Aggressive Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

Objective: aims to maximise capital growth after the base fund fee, but before tax over the minimum recommended investment timeframe.

Strategy: provides exposure to a diversified fund that primarily invests in international shares, with a moderate allocation to Australasian shares.

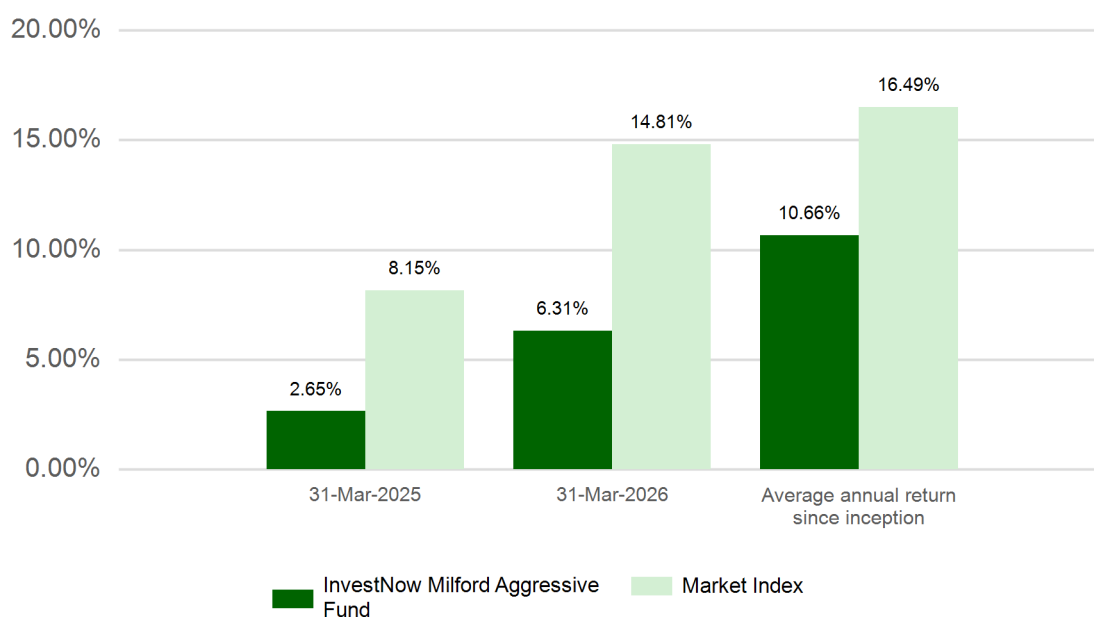

### Example of how this applies to an investor

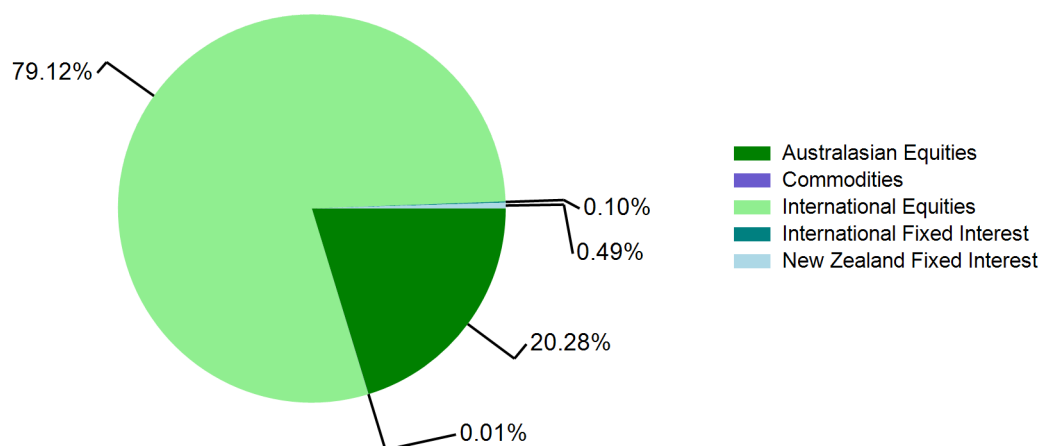
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,112 (that is 11.12% of his initial \$10,000). This gives Anthony a total return after tax of \$985 for the period.

This shows the types of assets that the fund invests in.

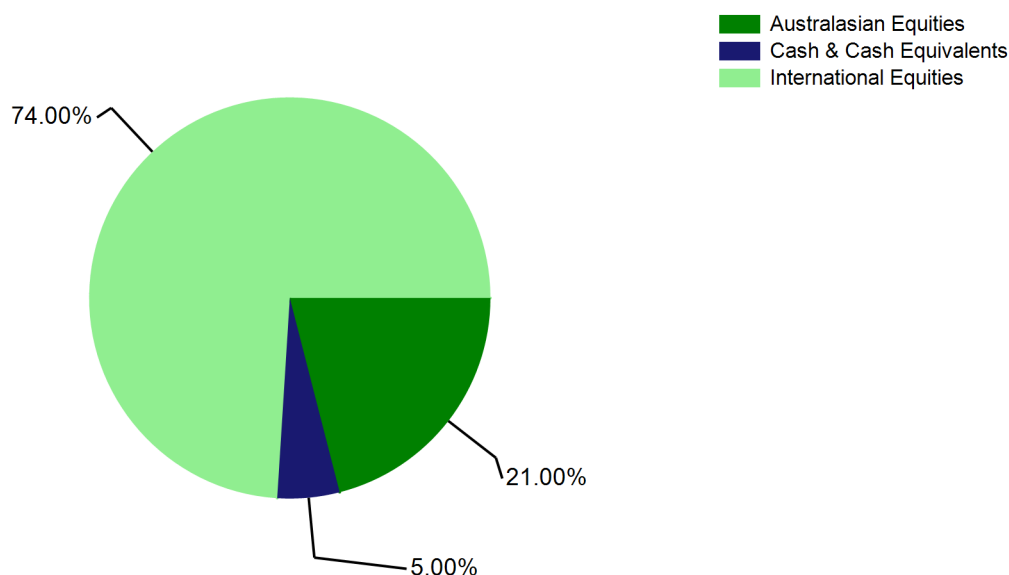
Actual Investment Mix

## Notes

- A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years.
