What is the purpose of this update?

This document tells you how the InvestNow Smart Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: designed for investors that want a growth investment option.

Strategy: provides exposure to a diversified fund that invests mainly in growth assets.

What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

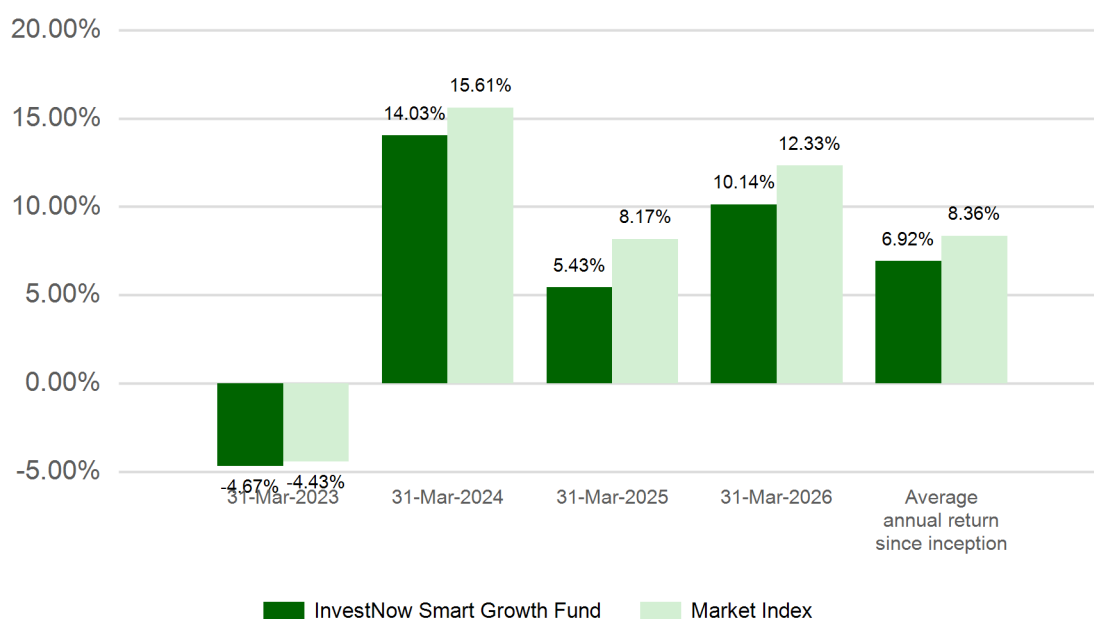

How has the fund performed?

What fees are investors charged?

Investors in the InvestNow Smart Growth Fund are charged fund charges. In the year to 31 March 2026 these were:

Example of how this applies to an investor

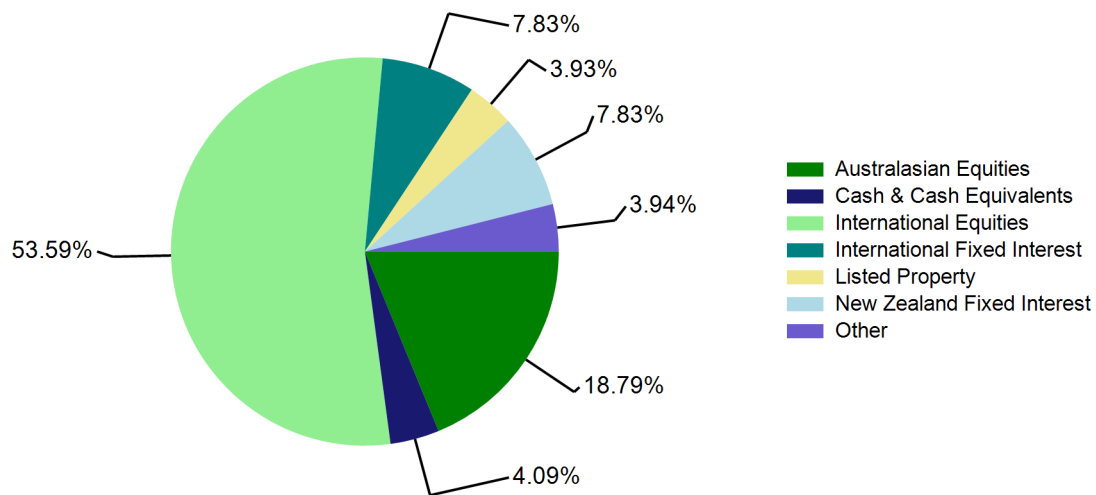
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,731 (that is 17.31% of his initial \$10,000). This gives Anthony a total return after tax of \$1,715 for the period.

This shows the types of assets that the fund invests in.

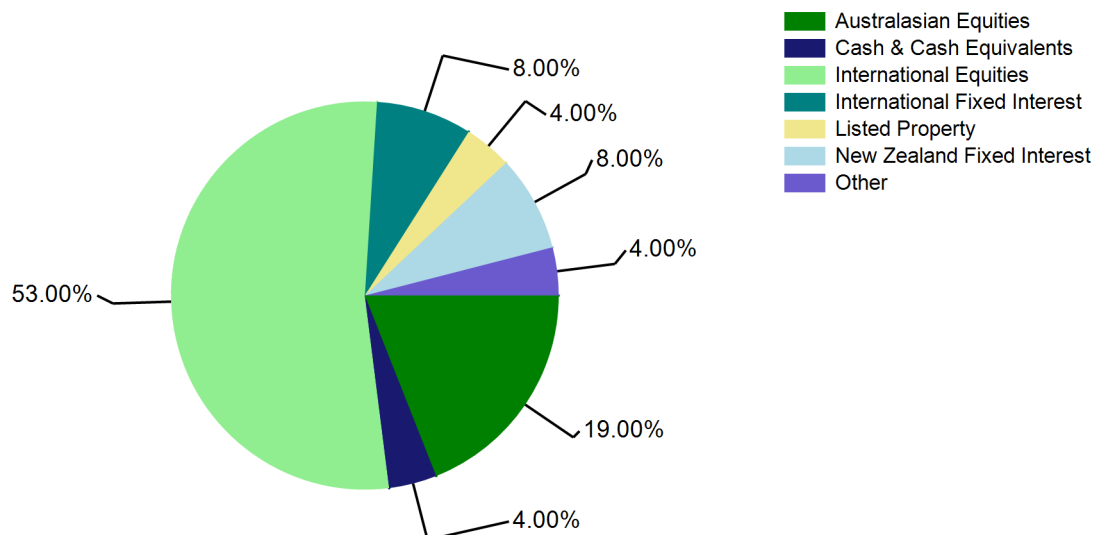
Actual Investment Mix

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 58.00%. The actual hedging level can be anywhere in the 0% - 120% range. As at 30 June 2026, 57.25% of the fund's foreign currency exposure was hedged

Notes

- A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years.
